tute or lewd woman, or who is in fact a prostitute or lewd woman, it shall be prima-facie evidence that they are together for unlawful purposes as prohibited in the last two preceding sections. (Sec. 3, Ord. app. Feb. 2, 1914.)

## PENALTY.

Sec. 149. Any person found guilty of violating the provisions of the last three sections shall be fined in any sum not more than one hundred dollars to which may be added imprisonment in the city jail for not more than three months. (Sec. 4, Ord. app. Feb. 2, 1914.)

# CHAPTER 24.

# CRIMES AGAINST PUBLIC HEALTH AND SAFETY.

# IMMODERATE RIDING.

Sec. 150. If any person immoderately ride or drive any horse in any avenue, street, alley or lane within the limits of this city, every such person shall upon conviction be fined in the sum not less than five dollars nor more than one hundred dollars. (Sec. 14, Ord. app. June 10, 1887.)

## CARRYING WEAPONS.

Sec. 151. It shall be unlawful for any person in the City of Buffalo to keep or bear upon the person any pistol, revolver, knife, slung-shot, blow-gun or any lethal weapon, except the officers of the United States, of the State and of the City; any person convicted of a violation of this section shall be fined not less than ten dollars nor more than fifty dollars. (Sec. 43, Ord. app. June 10, 1887.)

# RESISTING ARREST.

Sec. 152. Any person or persons who shall resist by force and violence, or who shall encourage, aid, abet or assist any other person to resist by force and violence any arrest made or attempted to be made by the marshal or any police officer of this city or who, standing by, shall refuse to assist such marshal or police officer in making such arrest if called upon so to do by such marshal or police officer, shall upon conviction thereof be fined in any sum not less than five nor more than one hundred dollars for each and every offence. (Sec. 40, Ord. app. June 10, 1887.)

# POISONS MUST BE LABELED.

Sec. 153. If any person shall vend, give or deliver within this city any deadly poison, knowing the same to be such, without marking the same in legible characters "poison," every such person shall upon conviction be fined in a sum not exceeding one hundred dollars. (Sec. 15, Ord. app. June 10, 1887.)
