

Drag Queen Bingo, our annual fundraiser, employs prevention messages and information throughout the event. Our plan is to educate the attendees about HIV/AIDs as well as safe sex practices and prevention while providing the perfect opportunity to encourage testing, knowing your status, PrEP, and prevention. These messages are presented leading up to the event and throughout the night of the event in addition to condom distribution, prevention literature, and free HIV testing conducted by Albany County Public Health.

Goal *

Our first goal is to provide an event that increases the attendee's availability to HIV testing and education. We create a fun environment in which to learn and know their status in an environment that is non-judgmental and free of stigma. Our second goal is to have a successful fundraising event that raises funds for the Client Assistance Fund and increases knowledge and awareness of what we do and how we help. And finally, we have the goal that attendees leave the event knowing more than when they arrived about a variety of topics including testing sites, safe sexual practices, the importance of knowing their status, and the benefit of Wyoming AIDS Assistance to the community.

Impact Statement *

How will this activity address the need(s) of the population and meet your stated goal?

The target for Drag Queen Bingo is multifaceted. We target people over the age of 18, but they come from all walks of life including MSM, HIV/AIDS positive, college-aged students, general public, and community members. Advertising is conducted primarily via social media in order to reach these target populations as well as our community members in the more rural areas. To date, the money that we have raised has assisted HIV/AIDS positive people with their medical, dental, vision, housing, and mental health care costs. We have raised over \$380,000 that has helped countless people avoid eviction, purify their water, and pay for expenses that insurance or other assistance programs don't cover, supporting positive individuals and contributing to their overall health.

One measurable outcome *

Examples:# of people served or attended, #tested, % decreased or increased over specific time period, pre/post survey results, etc

At the event we will disseminate an evaluation to all participants and these will be collected at the end of the night. We have found that we do get a good response from the attendees. This form is designed to collect information about participants as well as delivery of information and change in behavior. Specifically, we hope that 25% of all attendees fill out the evaluation and, of those received, 40% report that they learned during the event and will strive to know their status.
